RULES & REGULATIONS

- I agree to abide by all the rules, regulations, dojo etiquettes and procedures of organization 'Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India Shito-Ryu Karate-Do International Renshikan' (Henceforth organization will be referred as JKNSKI) which may be updated from time to time.
- I also have NO OBJECTION if JKNSKI uses my-self / child / ward's pictures, videos, names etc. as an advertisement through newspaper, internet, brochures and banners or in any electronic or print form.
- I am aware that Karate-Do is primarily a martial art and I agree to act with full responsibility and shall NOT MISUSE it in any case. I will only use my martial arts skills in case of danger or emergency for SELF-DEFENSE, PROTECTION FOR MY FAMILY & NATION according to the laws of land.
- I will not indulge or participate in any unlawful activity or action which might be harmful to anyone or damage the prestige and honour or Karate-Do, Karate organization JKNSKI or the institution where the training is conducted.
- The JKNSKI can make modifications to the class schedule if necessary this may include altering the current class schedule, closing school on public holidays, for special karate events, meetings or due to any other reasons. Such modifications do not relieve the students from the payment obligations.
- I am aware and agree that physical contact will be used by principal instructor, instructors, examiners, officials, students, authorized individuals of JKNSKI during teaching, training, testing, demonstrations, competitions, seminars, camps lectures etc. for which I have full consent to any physical contact as may be required or essential to martial arts, self-defense training or for the first aid.
- The JKNSKI can also cancel a batch if there are not sufficient students in a batch required to function.
- Student's failure to attend training session does not relieve the obligation to pay the agreed training fees for the month in full. **No fees are refunded in any case once paid.**
- The JKNSKI do not warrant that the use of protective equipments will completely eliminate the possibility of injury or accident but shall reduce the risk of injury or accident. In recognition the possibility of injury or accident connected with martial arts training in JKNSKI, I waive all my rights or causes of any action arising from such activities and any liabilities against the JKNSKI, its volunteers, Instructors, Principal Instructors, Technical Director, Employees and the managing committee. Students need to carry their own Karate-Do Uniform and complete Karate Kit (Gloves, Shin-pad, Headgear, Chest guard, Gum shield etc.) required for training.
- I understand and aware that 'Karate-Do' is primarily a martial art and a hazardous contact sport and my participation in Karate-Do training, test, competitions, demonstrations, seminars, camps or for any unforeseen circumstances which can lead to any kind of injuries (both minor or major), mishap and in some case even loss of life and by signing this registration form I agree to accept full responsibility for my-self / child / ward and declare that JKNSKI and its Principal Instructor, Technical Director, Officials, Instructors, Volunteers shall NOT be held responsible in any case.
- The JKNSKI student should not share knowledge with other style members nor engage in any other form of martial arts training.
 - The JKNSKI student not allowed teach martial arts without the written permission of the Principal Instructor & Technical Director Naresh Sharma Renshi of Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Shito-Ryu Karate-Do International Renshikan) if found disciplinary action will be taken which can lead to expulsion or suspension and not allowed to teach within 50 km radius of our Dojo (JKNSKI training centre) during term of this contract and during a period of 10 years following dissociation with JKNSKI.
- Upon violation or infringement of any JKNSKI rules & regulations mentioned above or explained later, misbehavior, involving in any type of illegal activities shall lead to disciplinary action which includes suspension, expulsion and in some case even legal action will be taken against the student.
- I agree and understand that participation in training, KYU / DAN grade examinations, competitions, training camps, seminars and workshops is mandatory part of Karate-Do learning and training which can't be omitted.
- I also agree and aware that certificates issued by JKNSKI is not accepted for any govt. jobs and have NO OBJECTION for my participation in Kyu/Dan grade examinations, competitions, training camps, seminars, workshops etc.
- JKNSKI teaches highly advanced Karate techniques to its students hence students should remain respectful, sincere and loyal towards the JKNSKI and its Principal Instructor, Technical Director & Instructors.
