RULES & REGULATIONS (Please read carefully before signing)

- Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan) imparts a highly technical and advanced form of traditional Japanese martial art, Nobukawa-ha Shitoryu Karate-Do. Therefore, students are strictly **prohibited from sharing, demonstrating, or teaching** any techniques or knowledge without **prior written authorization from JKNSKI Headquarters**.
- I hereby declare that I have **no objection** and voluntarily apply for the **KYU Grade (Belt) Examination** for myself / my child / ward at **Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan)**. I understand and agree that **appearing for the examination does not guarantee promotion**, and I accept all examination-related decisions made by **Naresh Sharma, Principal Instructor & Licensed Examiner of JKNSKI**, as final and binding.
- I agree and acknowledge that **examination fees must be paid in advance** along with the application form and that **fees once paid shall not be refunded under any circumstances**.
