TERMS, CONDITIONS & UNDERTAKING
(FOR DAN GRADE EXAMINATION)

- I agree to strictly abide by all the **rules, regulations, dojo etiquette, codes of conduct, and procedures** of **Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan)**, hereinafter referred to as **JKNSKI**, as prescribed and amended from time to time.
- I am fully aware and provide my **informed consent** that physical contact may be involved during teaching, training, testing, examinations, demonstrations, competitions, seminars, camps, lectures, or first-aid situations by the **Principal Instructor, Instructors, Examiners, Officials, Students, and other authorised persons** of JKNSKI, as required for martial arts instruction and safety.
- I understand that JKNSKI imparts a **highly technical and advanced form of Japanese martial art, Nobukawa-ha Shito-Ryu Karate-Do**. I agree to remain **respectful, disciplined, sincere, and loyal** to JKNSKI and its **Principal/Chief Instructor, Technical Director, and Instructors** at all times.
- I acknowledge that no JKNSKI student is permitted to **teach Karate or train under any other martial arts style or organisation** without **prior written permission** from the **Principal Instructor of JKNSKI**. Any violation shall result in **disciplinary action**, including suspension or expulsion, and restriction from teaching within a **50 km radius of any JKNSKI Dojo** during the term of association and for **10 years after dissociation**.
- I hereby declare that I have **no objection** and voluntarily apply for the **DAN Grade Examination** for myself / my child/ward at JKNSKI. I understand that **appearing for the examination does not guarantee promotion**, and I accept all decisions of **Naresh Sharma, Principal Instructor & Licensed Examiner of JKNSKI**, as **final and binding**.
- I agree that **examination fees must be paid in advance** along with the application form and that **fees once paid are strictly non-refundable under any circumstances**. However, candidates absent due to genuine emergencies or official detention may reappear after one month **without payment of additional fees**.
- I fully understand and acknowledge that **Karate-Do is a traditional martial art and a hazardous contact sport**, and participation in training, testing, examinations, demonstrations, or unforeseen situations may result in **minor or serious injuries, accidents, or, in rare cases, loss of life**. By signing this form, I voluntarily accept **full responsibility** for myself / my child/ward and agree that **JKNSKI and its Principal Instructor, Technical Director, Officials, Instructors, Volunteers, and Managing Committee shall not be held liable under any circumstances**.
- I undertake not to engage in any **unlawful, unethical, or immoral activities** that may cause harm to any individual or damage the **prestige, discipline, and honour** of Karate-Do, JKNSKI, or the institution where training is conducted.
- I agree to practice Karate-Do with **discipline and restraint** and undertake **not to misuse** martial arts skills under any circumstances. Such skills shall be used **only for lawful self-defence**, protection of family, and in the interest of the nation, strictly in accordance with the **laws of the land**.
- I hereby grant **full consent** to JKNSKI and its authorised officials to use photographs, videos, names, or related media of myself / my child/ward for **promotional, educational, or publicity purposes** through newspapers, the internet, brochures, banners, or any electronic or print media, without any compensation claim.
- I acknowledge that **certificates, grades, competitions, seminars, camps, and Kyu/Dan certifications issued by JKNSKI** are solely for validating training and proficiency in the martial art practised and are **not recognised for government jobs, school admissions, or college admissions**.
- I understand that any **misconduct, indiscipline, violation of rules, or actions harming the reputation of JKNSKI** may result in **strict disciplinary action**, including suspension, expulsion, penalties, and, where applicable, **legal action**.
- JKNSKI reserves the **absolute right** to terminate membership, cancel or withdraw examinations, and revoke certificates **without assigning any reason**, if a student is found involved in **anti-organisational or unethical activities**.
- I understand that JKNSKI may **modify or reschedule examination dates** when required, without prior notice or explanation.
- I acknowledge that the use of **protective equipment reduces risk but does not eliminate the possibility of injury or accident**. I voluntarily waive all rights or claims against JKNSKI, its officials, instructors, employees, and volunteers arising from participation in JKNSKI activities. I agree to carry and use the prescribed **Karate-Do uniform and complete protective kit** (gloves, shin guards, headgear, chest guard, gum shield, etc.) during training and examinations.
